Spruce Mountain District, 19 mi. from Jasper. Nevada Lead and Zinc Company CO-Leasers. See U.S.G.S. report.

White Rock, 57 mi. NW over Nevada 11. Boyce Brothers - owners. (lower adit 440' long, 85' raise to upper tunnel 200' long) Gold - Silver - Zinc.

Contact District (6.5 mi. W Contact) C. L. and T. S. Whitcomb and W. C. Lewis - owners. (Several small tunnels open cuts and an old inaccessible shaft 75'? deep.) Copper.

Spruce Mountain District, W slope Spruce Mountain. Milton Badt et al - Elko, owner. (incl sh. 65° SE on main fissure. 400' drifting on first 165' level. Two small stopes developed. Water stands just above 265' level. Lead - Silver.

5 mi. S Tuscarora near Tuscarora District. (J. W. Gainey, Tuscarora and W. B. Lenhart-owners). Adit with 30' winze sunk from adit level. X cut from bottom of winze 19' south and vein drifted on 15' W and 17' E. Several open cuts and widths 3"-5' go 4.4 to 204.5# Hg/ton. Mercury.
