NOGCC is a division of the Department of Conservation and Natural Resources. It has no employees. Day-to-day operations (issuing drillling permits, inspecting wells, etc.) are handled on a part time basis by William J. Newman (Ground Water Engineer, Division of Water Resources) who acts as the executive secretary of the Commission. Changes in regulations and other policy matters are established by the Commission which is made up of three members: (1) the State Engineer (Roland Westergard); (2) Director of the Nevada Bureau of Mines and Geology (John Schilling); and (3) a member appointed by the Governor (David Evans).

Describe the research capability of your agency. This may include in-house capabilities or capabilities conducted in cooperation with other governmental agencies or private consultants. NOGCC has no in-house research capabilities (by law, its function is purely regulatory). All research needed in the past has been done under contract by the University of Nevada's Nevada Bureau of Mines and Geology. NBMG is set up by law to do research on Nevada's geology and mineral resources, including petroleum and natural gas. NBMG maintains data files on the exploration for, and production of, natural gas and petroleum; these files are available to anyone needing this information. NBMG also does research on these subjects, which is published in reports and as maps. Provide any recommendations you believe would improve the ability of the State or your agency to deal effectively with renewable and nonrenewable resource activities. The 58th Nevada Legislature passed Senate Concurrent Resolution No. 8 (attached) directing the State Planning Coordinator's Office, in cooperation with affected departments and four representatives from the Legislature, to study possible reorganization of agencies dealing with renewable and nonrenewable resources. The Legislative Commission has appointed Senators Thomas R. C. "Spike" Wilson and Mary Gojack and Assemblymen Joseph Dini and Jean Ford as the representatives to work with the following department heads: Roger Trounday, Department of Human Resources; Elmo DeRicco, Department of Conservation and Natural Resources; Glen Griffith, Department of Fish and Game, and Tom Ballow, Department of Agriculture.

This group held its first meeting on July 17th to discuss the scope of the study, as well as the procedures to be followed during its course. There was agreement that the proper course of study would be to review in some depth the field of renewable and nonrenewable resources to determine if there are unmet needs, as well as to examine existing programs and organizations. Because of the important role that boards and commissions play it was agreed that for the study to be successful it would be essential for them to participate fully in the study.

Accordingly, the attached questionnaire was developed. Meetings have been scheduled at which time the legislative members of the committee and I will discuss with you these and other matters you believe may be relative and important to the conduct of this study. You have been tentatively scheduled to appear before the committee on August 27, at 3:30 o'clock in the Department of Agriculture's Conference Room, 350 Capital Hill Avenue, Reno.

Senate Concurrent Resolution No. 8-Senator Wilson

SENATE CONCURRENT RESOLUTION—Directing the governor's office of planning coordination to conduct a study of the problems resulting from the current organization of agencies involved with both renewable and nonrenewable natural resources in the various state departments, to make recommendations and to report to the governor and to the 59th session of the legislature.

WHEREAS, There are several state agencies involved in the use, regulation and conservation of both renewable and nonrenewable natural resources; and

WHEREAS, In past years, some of these agencies have been consolidated into state departments without regard to the basic difference between the

two types of resources; now, therefore, be it


Resolved by the Senate of the State of Nevada, the Assembly concurring, That the governor's office of planning coordination is hereby directed to make a thorough study of such agencies and all the problems related to their current organization in the various state departments with a view to improving the existing organization; and be it further


Resolved, That such study be carried out in cooperation with the directors of the state department of conservation and natural resources, the Nevada department of fish and game, the state department of agriculture of the State of Nevada, and the department of human resources, together with two senators and two assemblymen interested in natural resources matters to be selected by the legislative commission; and be it further

Resolved, That the governor's office of planning coordination report the results of such study to the governor and to the 59th session of the Nevada legislature, together with recommendations for any necessary and appropriate legislation.

SCR-8 STUDY DEFINITIONS

- 1. Nonrenewable Natural Resources A fixed quantity or supply of non-manmade material land, air, water and minerals.
- 2. Renewable Natural Resources Any material that is non-manmade that is variable in quantity and/or supply agricultural products, fish and wildlife, and forests.
- 3. Recreation Enjoyment of nonrenewable and renewable natural resources for other than financial gain.
- 4. Program The means or system whereby a goal or function is carried out or met.
- 5. Manage To identify, influence or manipulate a natural resource.
- 6. Regulate To govern or direct according to either statutory or administrative rule.
- 7. Department The major administrative unit with the agency head answerable to and appointed by the Governor or an independent board or commission with policy setting authority. The Department is charged with and has the authority to implement one or a series of programs through other administrative units.
- 8. Division The principal administrative sub-unit of a department charged with implementation of one or more related departmental responsibilities. A division may receive its policy direction from the department head or from a policy board. Where there is a policy board, the division head is responsible to the department head for administrative direction. The authority of the division head is only that delegated by the department head or statute.
- 9. Bureau An administrative sub-unit of a division charged with implementation of one or more related divisional responsibilities. The authority of a bureau can be the same as the division, and the creation of a bureau is usually to improve the administration of a large multi-program division. However, the bureau head answers to the division head.
- 10. Section A unit of either a bureau, division or department charged with implementing a specific function or program.
- 11. agency A generic term applying to any entity of government organization.
- 12. Ecology That phase of biology that deals with the mutual relation between living things and their environment.
- 13. Environment Everything in the universe external to a particular organism.
