GEOLOGY AND ORE OCCURRENCE

Formation slate and shales having strike of about N. 80° W. and dip normally about N. 80° E. The vein containing stibnite lies in a shear zone which strikes N. 45 W. and dips about 30° SW. On hanging wall side of vein is a vein of quartz that ranges from 2 inches up to 18 inches in width. High-grade stibnite occurs in the quartz from 2 inches to 6 to 8 inches in width and for varying lengths up to 30 feet. Stibnite is rarely disseminated throughout the mass of quartz.
