As I told you at Reno, I am after the Western Pacific for a reduction of freight rates on concentrate and have promised to give them all our business if they will take the initiative in making a substantial reduction.

I have also told them that our costs of marketing the concentrates are so high that we are experimenting with local treatment. As a matter of fact I have Mr. E. H. Mohr, Consulting Metallurgist for the Nevada Consolidated, working on the problem now along the lines of chloridizing roast and cyanide treatment. I understand that this method is in use in Mexico on ores resembling ours and hope for some success along these lines. It might be well for you to use the same argument.
