In response to my request to Glenn Waterman, whom I have known for many years, for information on the Bolly Varden district that could be published, he suggested that I write directly to you.

The U.S. Geological Survey and the Nevada Bureau of Mines have for some years cooperated in publishing a series of bulletins on the Geology and Mineral Resources of each of the 17 counties in Nevada. The report on Elko County--updating Nevada Bur. Mines Bull. 54--is in preparation, and I have been assigned the section on mineral resources.

There is a statement in USGS Bull. 648 (Hill, 1916, p. 82) that an outcrop near the Victoria mine resembles a leached porphyry copper. I would like to summarize in a sentence or two when the deposit was explored and what, where, and how much was found. If it has already been published, I do not have the reference.
