THE BLEWETT - WATSON PROPERTY

The Blewett-Watson property comprises six claims located at Golden Arrow, Nye County, Nevada. Two of these claims are located along a vein which strikes about N 50° E and dips from 70° to 80° east. This is the same vein that is developed at the Kiernan property - adjoining on the north. The vein material is quartz and silicified rhyolite somewhat oxidized. The vein width varies from 1 1/2' to 4' with both walls strong and distinct. The country rock is rhyolite - silicified in places. The vein has been opened up along the surface by numerous shallow open cuts for a distance of about 1000 feet. The second claim on the vein is covered by considerable wash and no work has been done here to find the vein.

The main shaft is located near the north end line of the Pocohontas claim - as close as possible to the Kiernan workings - where there is said to be considerable high-grade ore. This incline shaft is about 100 feet in depth on the vein, and about 70 feet of drift has been driven at this depth.

There are two other shafts on the vein - one of them 40 feet in depth and the other about 60 feet. There were no ladders available to enter these shafts but the vein appeared to be strong and well defined at both places.

The accompanying plate gives the location of the samples taken and the assay results.

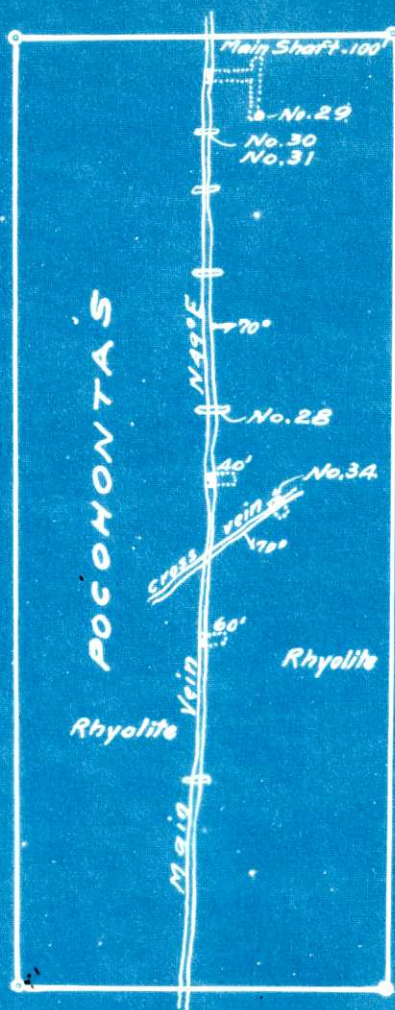
Terms

Total price of \$20,000 for the six claims - with a small cash payment at the end of three months from the date of option.

Conclusions

Assay results indicate that the main vein is too low-grade to be worked.

The cross vein shows high grade ore in a picked specimen but the vein showing is not strong.
