The purpose of this information sheet is to provide a list of maps and other documents that the Bureau of Land Management has available to the public. The Bureau of Land Management does not sell topographic maps. These maps are printed by the U.S. Geological Survey and can be ordered from their office at the Federal Center, Denver, Colorado 80225.

#### GENERAL MAPS

BLM QUAD MAPS - These are paper maps covering an approximate area of 30 miles by 50 miles at a scale of 1 inch = 1 mile. It takes 99 of these maps to cover the entire State of Nevada. Each map shows general land status as of the date of their printing, which may be as long ago as 15 years. The maps also show such cultural and physical features as 1000 foot contour intervals, major peaks and mountain ranges, drainages and valleys, rivers, lakes, springs and reservoirs, cities, towns and major ranches. Federal, State and County roads, along with jeep trails and railroads are also shown. BLM Quad Maps cost \$2 each and may be ordered by their respective number, as shown on a Quad Map Index.

BLM MASTER UNIT MAP - These maps are at a scale of 1/2 inch = 1 mile and each cover an approximate area of 42 miles by 45 miles. Because these maps overlay considerably, 111 separate maps are needed to cover the entire State of Nevada. The BLM Master Unit Maps depict the general land status, cultural and physical features shown on the Quad Maps. Master Unit Maps were revised recently and have land status current as of 1962 and in some cases as recent as 1964. Master Unit Maps may be ordered by the name appearing on the Unit Index Map at a cost of \$1,50 each.

#### LAND STATUS

BLM maintains land status records for the entire State of Nevada. The records include up-to-date maps of individual townships known as Master Title Plats. The plats do not show cultural or physical features, but only land status. Each plat covers only one township (6 miles by 6 miles) and will show which lands are Federal lands, private (patented) lands, rights-of-way, etc. The plats do not show current ownership of private lands. In some instances where ownership creates a complex pattern, additional plats known as Supplemental Sheets may be added for clarity. Normally the Supplemental Sheets are at a larger scale, 4 inches = 1 mile. Each Master Title Plat is accompanied by one or more Historical Index Sheets which contain a chronological list of all past and present actions affecting use of, or title to, the public lands in a township. In addition to Master Title Plats and Historical Index Sheets, there are Oil and Gas Plats showing oil and gas leases, and Use Plats that show other mineral leases. The Oil and Gas Plats and Use Plats also show

some of the title information found on the Master Title Plat. Master Title Plats, Historical Index Sheets, Supplemental Sheets, Oil and Gas Plats and Use Plats are available at a cost of \$2 per sheet, and should be ordered by township and range.

#### LAND SURVEY RECORDS

Township survey plats, showing the distances and bearings between U.S. Government survey markers (section corners), are available for \$1 per township plat. Xerox copies of field survey notes are \$.25 per page, microfilm copies are \$.50 per page. Protraction diagrams of unsurveyed townships are also available at a cost of \$2 per township. These protraction diagrams contain the subdivision lines within an unsurveyed township as near as possible to the way the subdivision lines would appear when actually surveyed. Protraction diagrams are used for mineral leasing in unsurveyed townships.

All of the above should be ordered by township and range.

#### MINERAL SURVEYS

The Bureau has records of all mineral surveys of patented and unpatented mining claims along with the field survey notes. The mineral survey plats show the individual mining claims, the distances and bearings between the corners of the claim, acreage, name of claim and mining district, and the name of the surveyor and date of survey. There are also Mining District Connecting Sheets which show the relative position of mining claims within a Mining District. Often Mineral Survey Plats and Mining District Connected Sheets will involve several sheets. Mineral Survey Plats cost \$1, and Mineral Survey Field Notes cost \$.25 per page.

#### PATENTS AND OTHER DOCUMENTS

Copies of patents of public lands conveyed to private ownership are available at a cost of \$1 per page. If certification is required there is an additional cost of \$.25. Serial Register pages, which denote applications for entry on, or use of, public lands are available at a cost of \$.25 per page. Orders for patents or serial register pages should include legal description or serial number if known. Copies of similar documents such as public land orders, proclamations, executive orders, etc., are also available at the above prices.

#### BLM PUBLIC LAND GUIDES

Public land guides for the six BLM Districts in Nevada are available to the public, free of charge. The guides contain a detailed map of each district and a text explaining the public land program, recreational opportunity and other related information. These land guides may be ordered by writing to the Nevada Land Office, Bureau of Land Management, Room 3008 Federal Building, 300 Booth Street, Reno, Nevada 89502.
