Dear Sir: -

I noticed a few days ago in an eastern Newspaper that your company, the Tonopah Mining Co., were looking for mining property and having lived in Tonopah for sometime, or rather did live there a few years ago thought I would write you to see if I could interest you in the camp of Jarbidge. I am also acquainted with your Consulting Engineer Mr.

J. E. Spurr and was going to write him but did not know his address.

I believe that Jarbidge is one of the coming camps of this State and there are some properties here partially developed that are showing up in good shape and I believe can be got hold very reasonable or at least a controlling interest.

The one in particular that I am writing you about is the Bluster Consolidated Mines Co., ground. They have done considerable work on the property-something like three thousand feet of tunneling and drifting, etc., The property has been pretty thoroughly sampled and the cre averages around fifteen dollars per ton. The values go about four fifth in gold and one fifth silver. The owners claim that there is about fifty thousand in tons of probable ore. The lower tunnel cuts the vein at around three hundred feet in depth and there has been about four hundred feet of drifting done on that level and the ore shows up good on this level. There has been a winze sunk from this level to a depth of approximately one hundred feet and the bottom of the winze is all in ore that averages better that twenty-

five dollars per ton. The ore extends clear to the surface as has been proven by a raise and a shaft. The Company owns about two thousand feet on the strike of the vein. The ground is not patented. There is considerable wood in the district- I mean min for mining purposes as well as fuel. There is also sufficient water here to furnish power for mining and milling purposes and the Bluster Company ownes the oldest water right in the district from which they can get plenty of power for all purposes. The mountains are quiet high also very steep and a tramway ma would have to be built to transport the ore from the mine to a mill.

I believe that this property, or rather a controlling interest can be purchased very reasonable and on reasonable terms. They will give at least thirty days after a man gets here within which to make an examination of the property.

If you, or your Company would care to do anything with this property and will let me know I will do the best I can at this end until such time as you can get an Engineer in here.
