
I did not find any transfers of title between Fred Steen and Fred Steen, Jr. So far as I could tell, this would be two separate people. However, I may be wrong in this.

Subject Field trip with Mr. Fred Steen

Location No. 1: An area between the Divide and Klondyke Mining Districts.

History of the area:

According to Mr. Steen, there was some activity in this area about 1917. A Mr. Charles Kielhofer, now deceased, staked out a townsite and did some mining and drilling on promotional money. At one location there is a two compartment shaft over 100 feet deep. No evidence of any ore bodies being discovered.

At another nearby location, they core drilled on a 40° angle to a depth of 150 feet. Mr. Henry Martin reported seeing them pull the core and reported it looked like good gold ore. Mr. Steen reports that the area from the shaft to the Divide Mountain should be looked over by a geologist.

A couple of miles East of the shaft there is a mineralized knoll that is pock marked with diggings. Some high and low grade gold ore was taken from this location. This area was relocated in May of 1969.

Otherwise, the whole area seems to be open ground. This whole area is referred to by the old timers as being the Gold Seam area. The gold that has been discovered comes in seams.

Note: Near this area is where Mr. Steen and his companion had the doodle bug working for them and brought in some of the cores from the drilling and some rock from the area.

Location No. 2: Southwesterly from the heart of the Klondyke Mining District.

In this area Mr. Steen has 4 claims, the Payday Group. They are overlapped in part by the Hughes Tool Company claims, the Half Ways, near the area of the NE Corner of the Half Way No. 1 and the NW Corner of the Half Way No. 2.

A quarter mile Northerly from this location, Mr. Steen reports that on the surface they have got gold that went from \$2 to \$4 a ton and also sheelite values. The ledges outcrop in this area, and in one shaft the water table is 20 feet below the ground level.

Subject Field trip with Mr. Fred Steen

In the early days, about a mile NE, some orentials panned for gold extensively. In the valley several miles from this area is the old railroad station. Near this station, years ago, Mr. Pennington and partner, dug a shaft in the loose gravel, 45 feet deep. They reported panning for gold as they dug the shaft and got colors throughout this depth. They did not get to bedrock.

Evaluation:

This is hungry looking country on the surface. The underground geology may offer brighter prospects and opportunities.

PARCEL NO. 2 - PAYDAY GROUP KLONDYKE MINING DISTRICT

Group consists of four unpatented mining claims, situated in the Klondyke Mining District, Esmeralda County, Nevada.

Ground lies about one half way between Goldfield and Tonopah, and about one mile North of main highway in low rolling hills, and about one mile South of the old Klondyke mining area, which is the nearest productive area. The production figures for the old Klondyke area for the period 1908 to 1921 are shown in an edition "Mining Districts and Mineral Resources of Nevada", written by Francis Church Lincoln, and are broken down as 11,836 tons of ore containing \$36,467 in gold; 277,466 ounces silver; 3,472 pounds copper and 217,147 pounds lead; values in all \$263,700.00 according to Mineral Resources of the U.S. Geological Survey. Production continued after 1921, but figures are not readily availabe.

On the Payday Group a series of tungsten exposures have been uncovered by shafts, open cuts and bull dozing. Gold and sheelite are found in placer in gulches on the gound, and some values have been obtained from surface formations. The formation is lime and rhyolite. Lime formations carry low gold values. Placer gold is sharp indicating it has not traveled far from its original source. To the East of the Payday Group in a gulch running along the base of a rhyolite hill, considerable gold was recovered by dry washing. Below the hills the terrain extends into a large open flat basin, and bed rock is covered by gravel to quite a depth. A study of the section that was dry washed could very well bring in an extension of this main channel, which could then be followed into the area below the hills.

The Payday Group lies in a direct line between Goldfield, Divide District and the Tonopah District. A water of
source extends from the South of Goldfield, through Goldfield,
to the area where the Payday Group lies, Divide and Tonopah, and
continues to the North to the old Liberty District and others.

Good ore has been mined in all of these districts, and a drilling
program on the Payday Group might open up better values at a
shallow depth.

Water can be had from a well on the ground, and further to the South of the property several wells produce a good water supply. There is no timber on the ground. Electric power line extends from Alkali station to Tonopah, a few miles distant from the property.
