ORDER SETTLING FIRST AND FINAL ACCOUNT
AND DECREE OF FINAL DISTRIBUTION

COMES NOW DOROTHY BOSCOVICH, as administratrix of the estate of GEORGE BOSCOVICH, deceased, and proves to the satisfaction of the Court that her First and Final Account of Administratrix, Report of Administration, and Petition for Final Distribution was rendered and filed on March 23, 1970, and the same regularly coming on for hearing before the Court, after notice being given in the manner required by law, and no person appearing to except or contest the said Account or Petition, the Court, after hearing the evidence, finds that notice to creditors has been given in the manner and for the period prescribed by law; that all of the allegations of said petition are true; save and except the allegation that the subject property was the separate property of deceased, the Court finds that the subject property was the community property of deceased and DOROTHY BOSCOVICH; that all claims presented against said estate have been approved and paid, and that all expenses of administration, excepting the attorneys' fees and fees of the Administratrix have been paid; and that said Account should be settled and distribution of the estate of said decedent, now in the hands of the Administratrix, should be made to the surviving spouse in accordance with N.R.S. 123.250.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the First and Final Account, Report of Administration, and Petition for Final Distribution heretofore filed herein by the said DOROTHY BOSCOVICH, Administratrix of the estate of GEORGE BOSCOVICH, deceased, be, and the same is hereby settled, allowed and approved.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that petition for Waiver of Statutory Commission by DOROTHY BOSCOVICH, Administratrix, of said estate be, and the same is hereby approved; and that Beko & Lemon, Attorneys at Law, attorneys for said Administratrix and said estate, be, and they are hereby awarded the sum of \$700.00 as compensation in full for legal services rendered as attorneys for the said Administratrix and said estate.

IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the residue of said estate now in the hands of said Administratrix, including the real property as listed in Exhibit "Z" attached hereto and incorporated by reference herein, together with any and all other assets of the said estate that may be hereafter discovered within the State of Nevada, be, and the same is hereby distributed to DOROTHY BOSCOVICH.
