Dear Sir:-

At the request of M.M.Gleason I am sending you under separate cover the report on the PIGEON SPRINGS MINING and MILLING Co's property in the LIDA MINING-DISTRICT, ESMEERALDA CO., NEVEDA. This property is better known as the OLD BUSTER MINE.

We had an option on this property which called for a payment on the first of the present month, but as this payment was not made, of course the option expired.
