"THE BLUE DICK" MINE

"The Blue Dick" is a familiar name to old timers of Nevada mining fame, discovery was originally made on this property about 1880, by a man who styled himself "Blue Dick", and together with his associates followed an outcropping on the apex of the mountain, which is the beginning of a D yke some two miles in length and with rich surface showing thrucut. These operators confined their explorations to the one location or claim known as "The Blue Dick", by sinking a shaft 135 feet in depth, afterward driving a tunnel about the same distance, and connecting with shaft at bottom, together with quite extensive drifting, they took out some \$375,000.00 in high grade ore and packed same to Austin a distance of approximately 80 miles; owing to inadequate transportation and other encumbrances this property became lapse and was subsequently re-located by present owners.
