

Dear Sir:- Tonopah, Nev.

The proposition that we have to submit to you is this. We have seven claims 5 Yellow Roses No's from 1 to 5 1 Kentucky and one Sunset making seven in all, all in one group, which we offer for six thousand dollars (\$6000.00), \$4000.00 for the Yellow Roses and Kentucky and \$2000 for the Sunset. \$1000 to be paid in 40 days from time of signing papers, \$1000 in 30 days, and balance in 60 days.

In answer to your letter of January 27th regarding  
Wildgrube claims located in George's Canon:

I visited these claims on February 5th.

Wildgrube's claims are located in the Monitor Range.  
There are no maps known to us that show the exact location. Pro-  
bably 20 miles northerly from Stone Cabin would locate them within  
a few miles. The claims can be reached by a .50 mile drive. The  
formation is rhyolite and very little fissuring or disturbance  
is shown.

Mr. Wilgrube could not show me a well defined vein during  
our three hours on the ground and I did not find any places that  
seemed worth prospecting.

Two assays were taken where some surface work had been  
done. No. 1 showed a trace of gold and silver and No. 2 showed  
16/100 oz. gold and 4.44 ozs. silver.


I do not consider the proposition worth considering even  
at the price of \$6,000.00.

Murphy and associates are leasing about two miles to the  
north. Fancher and Scarlock within a mile. The ore in neither  
is exceptional.

Jack Longstreet is reported as having sold his claims, which  
are about four miles from the Wildgrube property.

I will discuss this proposition with Messrs. Whiteman and
