Dear Mr. LaPrairie:

In accordance with the surface management regulations (43 CFR 3809), we recently inspected Bristlecone Mining Company's Paiute project in Washoe County, Nevada. This operation was conducted under Notice N36-84-040N, a copy of which is enclosed for your reference.

During our inspection, we observed that the 1989 roads and dozer cuts had been constructed both in the wash, as proposed, and on the steep slopes on both sides of the wash. We could not locate any drill holes on these new roads, but noted that older drill holes on the property remain unplugged.

The disturbances on steep terrain, including older roads constructed by Denison, lack erosion control measures and have already begun to erode. Slope slability problems and further soil loss are likely to result unless interim reclamation (waterbars, outsloping the road bed) is begun.

We are therefore requesting a status report for operations conducted under Notice N36-84-040N. In the report, to be submitted to this office within 30 days of receipt of this letter, please describe the current status of the project, as well as your plans to counter further erosion on the site.

GENERAL GUIDELINES 3809 RECLAMATION

A. ACCESS/DRILL ROADS

- 1. Keep to minimum width needed for safe operations. Grade should not exceed 30%. In steep terrain, track-mounted drill rigs should be considered as an alternative to road construction.
- 2. Follow the natural terrain where practicable to minimize cut and fill.
- 3. Stay in dry drainage bottoms as much as possible especially if roads are to be abandoned.
- 4. Roads that have a grade of less than 6% should be ripped to promote moisture infiltration and revegetation.
- 5. Roads that have a grade of greater than 6% should be ripped and properly waterbarred (see attached).

B. DRILL SITES

- 1. Drill in roadways where possible. Self-leveling drill rigs should be considered for steep terrain.
- All drill holes should be plugged with either cement or a mechanical device at least 5 feet below the surface. Drill cuttings will be disposed of down-hole and leveled with the surface.
- 3. Drill pads should be regraded to approximately match the natural contour. When pads require a cut and fill construction, the operator may be required to "pull" cast material upslope to aid in recontouring. Topsoil should be saved and spread following recontouring.

C. TRENCHES/PITS

All trenches and pits should be backfilled and recontoured upon completion of sampling and/or mapping. Excavations required to show mineralization may be left open temporarily. Trenches and pits should be constructed so they do not pose a hazard to humans or livestock. Fencing may be required.

D. SEEDING

Seeding requirements are based on a variety of factors including precipitation, type of soils, aspect and slope. Generally, if annual precipitation is less than 8 inches, seeding will not be required. When seeding is required, the District will make recommendations on a case-by-case basis.


Thank you for returning my call today concerning access to our mining claims in Big Mouth canyon. As we discussed, we have acquired a group of unpatented claims from Denison Mines who shut down their U.S. operations about two years ago.

Enclosed is a map showing the road which we wish to use for access to the claims from Highway 34. This road is not currently maintained and our use will be minimal. I have also noted on the map, with red circles, two areas where we would like to have permission for loading and unloading equipment. These areas were used by the previous owners for unloading the drill rig which they had contracted.

If you will grant us permission for access and use of this road we will indemnify and hold the Tribe harmless from any claims, demands or liabilities arising out of our use of the road and assume full responsibility for our use of the road.

Our work program for this year is for road construction to some of the old underground workings in the center of the property. This would entail no more than four vehicle trips per day for a period of approximately two weeks. In the event we step up operations and need heavier use of the road, we will contact you first to obtain permission for increased use and any necessary maintenance.
