

The Data below was obtained from records of the recorders office of Churchill County, Fallon, Nevada.

HIGH DIDDLE DIDDLE

#54511

This claim was located by M.P. Revsbech on October 2, 1937. The description of this claim states that it runs easterly 800 feet and 700 feet westerly from the discovery monument. Further description reads that the northwest corner is about 100 feet south of the Lincoln Highway and the northeast corner is about 250 feet south of the Lincoln Highway. The Annual Proof of Labor covering the work performed from July 1937 to July 1938 was recorded April 17, 1939 and that expenditures were made by or at the expense of M.P. Revsbech, owner of said claim.

DOUBLE ENDER NUMBER ONE

#54510

This claim was located by Hall Carpenter and M. P. Revsbech July 12, 1921. The description of the location is one quarter mile south of the Lincoln Highway, claiming 750 feet westerly and easterly from discovery monument.

M.P. Kevsbech deeded to G. C. White on February 17, 1926 all of his interest in said claim. Annual Proof of Labor from July 1937 to July 1938 was recorded on April 17, 1939. Expenditures were made by or at the exrense of G. G. White and M.P. Kevsbech in behalf of C. G. White, owner of said claim.

DOUBLE ENDER NUMBER TWO

#54510

This claim was located July 12, 1921 by Hall Carpenter and M.P. Revsbech giving the location as one quarter mile south of the Lincoln Highway and claiming 100 feet westerly and 1400 feet easterly from the discovery monument. This claim was deeded to C. G. White on February 17, 1926 by M.P.. Rewsbech. Annual Proof of Labor from July 1937 to July 1938 was recorded on April 17, 1939. Expenditures made by or at the expense of C. G. White and M.P. Revsbech on behalf of M. P. Revsbech, owner of said claim.

TWILIGHT NUMBER ONE: TWO, THREE, & FOUR

These claims were located on July 5, 1922 by J. W. Schnitzins and M.P. Revsbech. The location of these claims is four miles east of Sand Springs along the Lincoln Highway. Twilight No. 1 600 feet easterly, 900 feet westerly; Twilight No. 2 600 feet easterly, 900 feet westerly; Twilight No. 3 400 feet easterly, 1100 feet westerly; Twilight No 4 200 feet westerly, 1300 feet easterly, from discovery monument. The Annual Proof of Labor from July 1937 to July 1938 was recorded on April 17, 1939. Expenditures being made by C. G. White and M.P. Revsbech, owners of said claims. On February 17, 1926 2/3 undivided interest in the above group was deeded to C.G. White by M.P. Revsbech.

THE BLUE EAGLE FRACTION

We went through the records of the recorders of Churchill County but we were unable to find where the Blue Eagle Fraction was ever recorded, however, notice of Annual Proof of Labor for the year 1935 and 1936 was recorded on June 19, 1936. The Annual Proof of Labor covering work from July 1937 to July 1938 was recorded on April 17, 1939 with the notice that the expenses of said Annual work was by Edward Owens, M.P. Revsbech, and Clay Mills in behalf of Edward Owens, owner of said claim.

N.R.A. FRACTION

#54533

This claim was located by M.P. Revsbeck for Edward Owens in 1934. No Ennual Proof of Labor or exemption was ever recorded until April 18, 1939 covering the Annual Proof of Labor from July 1937 to July 1938. The Annual Proof of Labor shows that the work was performed by M.P. Revsbeck for Edward Owens, owner of said claim. Searching the records we found that the April Fool, the Noble Fraction and the South Guard Mining claims were never recorded.
