



1155 Level:

South X-C 1214 reached the Halifax line and was discontinued.

Work was started on a little quartz showing at coordinate 1540 S, 2830 E (D 1223), but the showing here is not very promising.

X-C 1224 is a small amount of work being done at coordinate 1040 S, 2780 E, where a short cross-cut is being driven to the south, just under the north-south fault which cuts off the Flat vein at this point, to make sure that the faulting here is not reverse. This cross-cut will be driven but a short distance, possibly 20 feet.

Winze 1007 is now 103 feet below the level, and is passing out of the hard quartz and into what is apparently lower Rhyolite Breccia, similar to that in the face of north X-C 1214.

Stoping has been discontinued until the returns from the cars already shipped to the mill have been received. The first car shipped was taken from D 1218 between K-C 1214 and a point about 50 feet to the east, and ran \$7.17 per ton. Two other cars were taken from the vein at a point just east of the cross-cut, and have not yet been heard from, but from the results of the daily samples taken while breaking the ore, it is thought that they will not run much higher than the first one. A fourth car, taken from R 1216 directly over R 1217 at coordinate 1100 S, 2780 E, ran \$16.54 per ton, and it may be possible to get another car almost as good from this same stope. The vein here, however, is very much faulted and the values occur in spots.

GENERAL

All development work planned, with the exception of

sinking the winze, has now been completed, and unless you have other work to suggest, operations will be practically confined to that work, and to stoping an occasional car of ore.

It is our intention to drive a raise at a steep angle to the east from X-C 1214 at about coordinate 350 S, in order to locate the Midway Andesite contact.

1155 Level:

South XC-1214 made the usual progress in trachyte This cross-cut will reach the Halifax line in a few more shifts, when it will be discontinued and work started on some quartz showing on the east side of the cross-cut some distance back.

Winze 1007 is passing through a body of hard barren quartz which lies under the flat fault mentioned last week. This has now been penetrated for a distance of about 30 feet and progress is necessarily somewhat slower than in the softer formations. The quartz shows occasional specks of pyrite but samples show it to be practically barren.

The second car of ore was sent to the mill the latter part of the week, and a third car is now being hoisted.

Following is a transcript of the essential portions of the report of our superintendent on the Mizpah Extension lease for the fiscal year ending April 30, 1916:

"The following is a report of the mining operations of your company at the Mizpah Extension Lease for the fiscal year ending April 30, 1916:-

SURFACE IMPROVEMENTS:

During the year a one-inch water line was installed, connecting the Mizpah Extension shaft with the Tonopah Water Company's mains at the Belmont shaft, thus doing away with the old system of hauling water to the shaft in wagons, and affording protection in case of fire.

An addition to the transformer house was built, and two new K.W. Transformers installed, to take care of the increased load on the old transformers, caused by the installation of a new hoist underground.

UNDERGROUND IMPROVEMENTS:

A new power line was placed in the shaft, and the underground power lines were re-hung in a workmanlike manner, and new and heavier wires were strung on the 1000 level from the shaft to the new hoist station.

A hoist station and ore pocket were cut at the top of the raise connecting the 1000 level with the 1155 level below, and a 50 H.P. hoist installed, the raise being enlarged to permit the operation of a one-ton skip. Both station and raise were well timbered. The work of sinking the winze a depth of 150 feet below the 1155 level is now under way, and the completion of this work will permit economical exploration of the eastern portion of the property at greater depth, and will afford an outlet for any ore which may be developed by these operations.

A 3/4 inch water line was installed on the 1155 level and connected with the water column on the 1000 foot level

of the Halifax shaft, thus furnishing water under pressure for use in the machine drills, and for laying dust.

The mine cars were overhauled and fitted with roller bearings to facilitate tramming as much as possible over the long trams on the 1155 level and between the new winze and the Mizpah Extension shaft. The tracks were also straightened, and new and heavier rails were laid where necessary.

About 75 feet of the main shaft was re-timbered, the work being done at odd times so as not to interfere with operations underground.

MINE OPERATIONS:

Operations were carried on continuously through the Mizpah Extension shaft throughout the year, with two shifts working a greater part of the time.

Very little waste was hoisted, nearly all of it being run into the old stopes of the Belmont Company.

It has been necessary during the year to make a great number of repairs and improvements in equipment, in order to facilitate mining operations as much as possible. At the present time, however, with the possible exception of further repairs to the Mizpah Extension shaft and the installation of a new blower on the 1155 level, everything at the property is in good condition, and costs for supplies and construction should be much less during the ensuing year.

DEVELOPMENTS:

During the first part of the year a small vein was encountered in the trachyte in north cross-cut 1214 on the 1155 level. This vein has a very flat dip to the north, and an east and west strike. It was drifted on to the east for a distance of 90 feet, when it terminated against the Midway Andesite or cap-rock, and to the west for a distance of 20 feet, where it is cut off by a westerly pitching, north-south fault. This gives a total length of 110 feet. At the point where the vein was first encountered, a raise was driven along its dip for a distance of 100 feet, when it was again cut off by faulting. This raise shows the vein to have an average width of about 3 feet, and a dip to the north of about 30 degrees.

An attempt was made to follow the vein down on its dip just west of the point where it encounters the Midway Andesite, but the flat north-dipping fault which forms the foot-wall at this point cuts the vein off just above the level, and its other segment has not been discovered.

The block of trachyte (Ore bearing formation) exposed on the 1155 level, has now been developed from its westerly boundary, where it is cut off by the Oddie Rhyolite, to its eas-

terly boundary where it comes in contact with the Midway Andesite; also, from the Halifax line on the south to its northern termination against the Tonopah Rhyolite breccia. The Andesite contact rises to the west at a flat angle, and overlies the trachyte at the eastern end of the 1155 level.

Development work in this block of trachyte on the 1000 level has resulted in the discovery of no veins of any value.

ORE RESERVES:

operations, which were started just before the close of the fiscal year, show the ore developed in the Flat vein to be very irregular in value, and consequently it will very probably be impossible to mine as much as was originally blocked out. A new assay plan has been prepared and is included in this report, and the ore developed is shown on the new plan, both as one large block "D", and as three smaller blocks, "A", "B", "C".

The large block "D", which includes the three smaller ones, contains 1660 tons of ore with an average value of \$9.07 per ton, figuring silver at 75 cents per ounce; and the smaller blocks contain a total of 723 tons with an average value of \$12.07 per ton. As the costs of mining, milling, etc., which will probably be about \$8.00 per ton, would be the same in both cases, it seems that it will be necessary to mine the ore as outlined in the smaller blocks, and that a conservative estimate of the ore developed at present is 723 tons with an average value of \$12.07 per ton. This estimate takes no account of possible ore which may exist below the level."

1155 LEVEL:

North XC-1214 passed through the fault mentioned last week, and entered the lower rhyolite breccia and was discontinued at coordinate 270S-2800 E.

South XC-1214 is still in trachyte and encountered nothing of value during the week.

Winze 1007 is now down 75 feet below the level. At a depth of 63 feet a very flat fault was encountered, striking a little east of north and dipping to the east. There is about two feet of quartz under the fault carrying a small amount of sulphides, and the appearance of the quartz and the fault is similar to that of the Oddie Rhyolite-Trachyte contact exposed on the level about two hundred feet to the west. The formation under the fault has not yet been determined, as the bottom of the winze is not clear of the faulting.

Stoping was continued on the Flat vein, and another car of ore is now broken and ready for hoisting. This car will be sent to the mill some time during the week.

The first car of ore shipped ran \$7.17 per ton, but it is thought that the next car will go a little higher, as only the better grade of ore has been stoped.



Report on MIZPAH EXTENSION LEASE for week ending May 8th, 1916:

1155 Level

North XC 1214 has passed out of the third period quartz and today is in a heavy fault, striking about N 60 E, and differs steeply to the south. If the formation beyond this fault does not look favorable for future development, work in this face will be discontinued. This crosscut has now passed through about 50 feet of black barren quartz, which at times resembles more nearly a highly silicified type of lower rhyolite breccia.

The location of the assay you refer to in your letter of May 2nd, is not right, as it should have been described as coming from \$1218, and not XC1214. The highest sample from the quartz in the cross-cut was 30 cents.

South XC 1214 is still in trachyte and following the east pitching fault. The face of this cross-cut is now at coordinate 1550S-2825E, and about 70 feet from the Halifax line.

Work in the winze is progressing nicely, and there has been no change in formation as yet, the bottom being in trachyte.

GENERAL

The monthly progress maps will go forward in a few days and will be dated as you request.

Mr. J.E.Spurr -2-May 9,1916. The face of North XC 1214 has run off the edge of our 40 scale tracing, so it will be necessary to paste a piece on the edge at that point, which will give you the exact location of the face, which is now at coordinate 28oS-2800E. R 1214 is in XC 1214 at coordinate 730S-2820E. The stope on the Flat vein shows the values to be very irregular, and the ore to be rather low grade. A car of ore was sent to the mill last Saturday (6th), and another will be sent out as soon as possible. 

None of the ore taken out during the development of the Flat Vein was stored on the dump because of the expense of hoisting through the old winze, and the lack of facilities for handling ore and waste separately. The small buckets on the old winze hold only about one-third of a car load; hence, it would have been necessary to dump the ore into the winze below the level and load the buckets from the chute below. If this had been done there would have been no place to dump waste, as it was being sent to the Belmont stopes through the same chute. Hoisting to the surface from this point would have required the services of four extra men. At the time we were developing this vein I suggested to Mr. Lawry that it might pay to save the ore, but after talking it over it was decided that nothing could be gained by it. All of these objections will be overcome, however, when hoisting through the new winze.



During the week the collar set was placed at the head of the raise from the 1155 Level, and the raise is now being enlarged and straightened. Work on the hoist station on the 1000 Level is also well under way.

1155 Level:

XC-1209 made the usual progress in trachyte and no veins were encountered. The face of this crosscut is now at Co-ordinate 1060S - 2625E, and it will be discontinued as it is now paralleling XC-1219 further east, which is in the same block of ground. 





During the week north cross-cut 1214 encountered a northeast, easterly pitching fault, under which at one point there is what appears to be a bunch of quartz carrying a large amount of pyrite. 

It will probably soon be necessary to plan some new development work on the Mizpah Extension Lease, and for this reason I think it best to acquaint you with the conditions on the property as they now are, and to suggest, for your approval, some development work which might prove beneficial.

The vein in D-1218 has been developed easterly to its termination against the cap-rock, and westerly to a north-south easterly dipping fault, beyond which its western continuation has not yet been located, although northwest drift 1219 is being driven with this object in view.Raising on the vein is in progress on top of, and just east of, the fault, and this raise should expose the vein on its dip, up to the cap-rock contact, which appears to be raising toward the east.

North XC-1214 is still passing through Mizpah Trachyte which carries numerous stringers of quartz, and will be continued as long as the cap-rock is not encountered. It is possible however, that the Oddie Rhyolite may be encountered as the contact with this rock where exposed further to the west has a north-east strike.

The flat south dipping vein drifted on in the most eastern part of D-1218 does not show in north XC-1214 except at about 75 feet north of D-1218 (950S - 2810-E) where there is considerable quartz showing in the top of the cross-cut. R-1213, fifty feet further north, passed through what is evidently this same vein about 10 feet above the level; the vein at this point lying practically horizontal, and being about 5 feet in width and practically barren. R-1215, 170 feet still further north, entered cap-rock about 35 ft. above the level without encountering the vein, which evidently assumes a south dip between the two raises and terminates against the cap-rock.

D-1219 will be continued to about co-ordinate 930S - 2700E and if no vein is encountered a vertical raise willbe put up at the face, with the assumption that the flat vein is somewhere overhead.

It has been found that three, and possibly four, machines can be operated to advantage, and there should be work planned ahead

so that this number of faces can be kept in continuous operation. Should XC-1214 enter an unfavorable formation without cutting a vein, should no vein be encountered in D-1219 or in a raise from this drift, or should R-1216 encounter the cap-rock, then there should be other places in which to place the machines, and it is with this point in view that I would like to get your opinion of the following suggested development work. Of course, should veins be encountered in the work now in progress development would be started on them at once.

- 1. Continue northwest D-1219 to the Oddie Rhyolite contact.
- , 2. Raise to the south on quartz exposed in the top of XC-1214 at co-ordinate 950S 2810E.
- 3. Resume work in south XC-1216 and drive to the south side-line or to the Midway Andesite contact.
- 4. Drive old north cross-cut 1200, which runs north from the main winze on the 1155 level and which is now in glassy Trachyte at co-ordinate 1350-S 1900E, north in an endeavor to locate Mizpah Trachyte on top of the glassy Trachyte.
- 5. Cross-cut south in Mizpah Trachyte on 1000 level from D1007 at co-ordinate 1430S 2500E, to south side-line
- 6. Drift west on quartz encountered in D-1007 at co-ordinate 1330S 2570E, which is just under the Midway Andesite contact.





1155 Level:

North crosscut 1214 is still in trachyte. The face is at coordinate 2820E-755S.

The fault along which east drift 1218 has been following has swung around to a north-south course and the quartz has been cut out entirely. The face is at coordinate 9805-2930E and we will now turn to the east at this point and drift east through the fault, in an endeavor to pick up the vein on the down-throw side of the fault. It is very probable, however, that we will go directly into cap-rock.

Work has been resumed in R.1211 on Company time and good progress should be made from this time on.

### GENERAL.

We will not be able to dump waste into the Belmont stopes until some bad ground over the stopes has been caught up by the Belmont Company.

The surface pipe line from the Belmont has been completed at a cost inside the estimate, and the water was turned on the first of the month.

Mr. Chandler tells me that the Halifax will be willing to do any work we wish done from their 1200 level. The work would be done through the Halifax shaft by their own men and we would be charged by the foot for the work according to its total cost. Mr. Chandler's costs for development work on the Halifax for the past few months have averaged between \$8.00 and \$9.00 per foot for drift work and about \$10.00 per foot for raise work, so we can assume that any work done for us would be at about this figure, which is considerably less than could be done through the Mizpah Extension shaft. They will also be willing to handle our waste under the same arrangement, namely, that we pay so much per car according to their total hoisting charges. As a protection to himself Mr. Chandler wishes to have a clause inserted in the agreement stating that in case a

flow of water is encountered while doing any work in our ground we would pay for our share of the pumping expense. Will you please advise me concerning this matter?

1155 Level:

North X-C 1214 is still in trachyte of a peculiar character, and containing small quartz veinlets.

East D-1218 is following a northeast fault, dipping about 30° to the southeast. The rock above the fault is doubtful and at times has the appearance of capping, but does not resemble the capping in the face of east drift 1211 further to the south. Below the fault there is considerable quartz; at times enough to form a solid vein. Part of this quartz is oxidized and resembles that of the vein which was cut off by the fault further back. We are following along the fault and keeping in the quartz below it.

The contractors in R-1211 did not make any headway during the week and decided to quit. The raise will be finished on company time.

We have made arrangements with the Belmont whereby they will be able to handle all of our waste for a considerable length of time. We still have to do a small amount of timbering in order to prepare their stopes for the waste, and as soon as this is done we will be able to discontinue hoisting once more.

1000 Level:

Northeast D-1007 reached a point where R-1211 may be connected with it and was discontinued.

There is now no work being done on this level.

1155 Level:

North X-C 1214 continues in trachyte without change. Only one shift per day was worked in this crosscut during the week, but workwith two shifts will be resumed shortly.

After drifting a short distance southeasterly from D-1218 at coordinate 1020S-2905E, the flat fault cutting off thevein was again encountered, so drifting to the northeast has been resumed in the old face at 1010S-2920E, which is all in waste. Do you think it advisable to try to trace this vein easterly from D-1218 at coordinate 1020S-2865E, to X-C 1214, where it does not show but is suspected to be immediately overhead?

The contractors in R-1211 encountered several difficulties during the week and there was not much progress made.

## GENERAL.

1000 Level:

Northeast D-1007 has almost reached a point directly over R-1211, and will be discontinued in a few days. I think this drift is now in cap rock, as there is considerable biotite present, the faulted zone which has just been passed through evidently being on or near the contact.

1155 Level:

North crosscut 1214 is still in trachyte, the rock being somewhat harder and showing more quartz stringers than for some time past. The face is at coordinate 810S-2820E.

The vein in east drift 1218 has been cut out entirely by a flat fault overhead. We will drop back a short distance from the face and try to follow the vein along a more southerly course; it is so flat here that it may be drifted on in almost any direction. The face of this drift is at coordinate 10108-2920E.

1000 Level:

Northeast drift 1007 has encountered what appears to be a quartz vein several feet in thickness, striking northwesterly and dipping to the northeast. The drift has penetrated the vein for about three feet with no hanging-wall showing as yet. The quartz has very much the appearance of silicified rhyolite and appears to be barren. Returns from a sample taken yesterday have not yet come in, but the vein as far as exposed does not have the appearance of commercial ore. The face of the drift is at about coordinate 1360S-2560W.

1155 Level:

North crosscut 1214 continued to make good progress with two shifts working. The formation still seems to be trachyte. The face is at coordinate 880S-2810W.

East drift 1218 is still following a flat vein 30 inches in width and carrying good values.

Work was started on the first of the month in Raise 1211. This work will be done under contract and good progress should be made.

#### GENERAL.

Enclosed you will find a sketch showing the relative position of the Halifax 1200 level and the Mizpah Extension 1155 level, the Halifax level being approximately 150 ft. lower than the Mizpah Extension level.

The Halifax level is in trachyte, but is to be discontinued as it is so far across the line. If this level were continued northwesterly for 350 ft. in the direction of the dotted line on the sketch, and a raise driven to connect with the Mizpah Extension 1155 level, it would supply good air to the Mizpah Extension workings besides prospecting the block of trachyte between the two levels. If arrangements could then be made with the Halifax people to hoist our waste, all of the waste from the 1155 level could be hoisted through the Halifax shaft and would result in a great saving in labor costs. The Belmont is again taking our waste but it will probably be for only a short time, as they

have but little room left for filling.

Mr. Chandler tells me that he would be willing to do this work under the same arrangement that was suggested some time ago, when itwas planned to have the Halifax drive a crosscut from their 1400 level; namely, to charge for the work according to its total cost. He was also of the opinion that satisfactory arrangements could be made for handling our waste if the connection were made.

Will you please advise me if you wish to have this work done, also if we should continue northeast D-1007 to the east beyond the point where it will connect with the raise from the 1155 level, as this point will be reached in about two weeks.
