Replying to your recent inquiry re the above corporation, you are informed that its charter was revoked (or, if a State other than Nevada is named after its corporate name above, its right to do business in Nevada was forfeited) at the time and for the reason set forth in one of the two following paragraphs which is checked:

- () The first Monday of March 19 , for failure to pay the annual license tax then assessed against corporations; or
- (*) The first Monday of March 19 30, for failure to file an annual list of officers, directors, designation of resident agent and his acceptance thereof, and to pay the filing fee and penalty thereon.

In either case, you are informed that the charter, or the right to do business in Nevada, as the case may be, has not been reinstated since revocation or forfeiture, for which the law authorizing the same makes provision. If you wish to reinstate the company, we shall be glad to advise you as to the total delinquent fees and penalties which must be paid before reinstatement can be allowed, and the procedure to accomplish such reinstatement.

You are further informed that corporations are not required to file in this office any papers, statements or reports, other than their articles of incorporation and any amendments thereof, notice of change of location of principal office and of the agent in charge thereof, and the annual list of officers, etc., above referred to, unless such corporations come within the scope of Chapter 318, Statutes of Nevada, approved 1963, requiring the registration of certain broker-dealers and agents and filing of disclosure statements. As the above mentioned corporation is not registered under Chapter 318, we are unable to inform anyone as to the physical or financial operations thereof, its property, assets, or liabilities; its stock issues; or the value of its shares, etc. Furthermore, we are never informed as to the registrar or transfer agent of its stock.

In view of the status of the company, as indicated above, we have no information with respect to the current officers, directors, or resident agent of the corporation.

By now you probably have received the three plastic transparancies showing the conflict area between the Carolyn and the Ponopah King Extension Claims.

You will note there is one doubtful area which is on the lower right hand portion of the map as between the "CM-" Claim and the TKE "A". Whatever conflict there might be as between the "CM-" and the TKE "A" as relocated is amply protected by the Hobo Claims which cover the entire conflict area and which were located by Fabbi prior to either the TKE or the Carolyn locations. This is also true of CM-255 in the same area.
